## **EastMidlands EMC Executive Board Meeting**

**EMC Executive Board** 

The EMC Executive Board met on 15 June, chaired by Cllr Jon Collins, Vice Chair of EMC and Leader of Nottingham City Council. The meeting considered;

Northamptonshire County Council - Summary of Developments - Members received a summary of recent developments at Northamptonshire County Council.

Infrastructure and Growth - Members were updated on HS2 in the East Midlands, the Midlands Connect initiative, and the latest position on the East Midlands Rail Franchise competition, and important developments relating to the incremental electrification of the Midland Main Line and the East Coast Main Line. These issues were discussed at the HS2 Strategic Board on the 29 of May 2018 chaired by Cllr Jon Collins, and the meeting of Transport for the East Midlands (TfEM) held on the 30 May 2019 chaired by Mayor Sir Peter Soulsby.

Asylum and Refugee Resettlement in the East Midlands - Members received an update on progress and key challenges for the East Midlands in respect of migration including the Asylum Dispersal and Syrian Vulnerable Persons Resettlement Programmes, Unaccompanied Asylum Seeking Children and wider asylum and refugee developments.

Local Government Employment Developments - Members received an update on significant issues relating to local authorities as employers. Councillors were invited to provide comments and feedback on the employment issues identified within the report to inform EMC's input to future Employers' meetings at Regional, National and European level. #### Migration



£19 million funding for councils to boost integration - Councils across England will receive a share of a further £19 million to help ease pressures on local services resulting from recent migration, Communities Minister Lord Bourne announced on 8 June 2018.

This latest allocation from the Controlling Migration Fund includes more than £16 million for 38 projects. The announcement includes £1.75 million of funding to help new refugees into work and

integrate into their new communities after their asylum decision is made. It also includes £1.1 million for 6 councils to support victims of modern slavery to link up with local services when they leave central government-funded support, thereby reducing their risk of becoming homeless, sleeping rough, or being re-trafficked. In the East Midlands, Derby and Nottingham have received funding as part of the Modern Slavery Pilots;

- **Derby, £175,000** Dedicated social worker support to assess victims' needs and manage care plans and the provision of community based support to develop independent living skills.
- Nottingham, £182,000 Caseworkers to work with victims being supported by the National Referral Mechanism to
  establish post-NRM plans and ease transition into the community. An evaluation of interventions is also being
  funded.

#### **Health & Social Care**



**ADASS Budget Survey 2018** - The annual ADASS Budget Survey is the an analysis of the state of adult social care finances in England. The data and analysis are drawn from the experiences of current leaders in adult social care. It provides contemporary, in-depth intelligence on how adult social care is responding to the multiple challenges of meeting increased expectations and need, whilst managing resources in an environment where Local Government funding is reducing, the

provider and labour markets are fragile and the impact is affecting, and affected by, what is happening in the NHS.

The results of this survey explore directors of adult social services' views of how councils are making incredibly difficult decisions in relation to the growing numbers of people requiring care and support with increasingly complex needs and with higher costs, where funding simply isn't keeping pace. Reduction in delayed transfers of care has been a priority, and the fact that adult social care has accomplished such reductions in the last year, following the injection of short-term funding, demonstrates that investing in adult social care gets results.

The survey data clearly sets out the concerns of councils in making increasingly difficult choices and their attempts to minimise the impact on people made vulnerable by their circumstances, with care and support needs, and their carers. The full report available <u>here.</u>

Meeting the health and wellbeing needs of young carers - This LGA publication on the health and wellbeing needs of young carers includes a range of case studies from across the country, including one from Nottingham, on developing a young carers app. The case study provides details of an app that has been developed for young carers in Nottingham, helping them to access advice and support and find out when activities are taking place. **Public spending on children in England: 2000 to 2020** - This IFS report provides new estimates of total spending by the government on children in England, including benefits, education spending, services for vulnerable children and healthcare. In the most recent year of data (2017–18), total spending was over £120 billion or over £10,000 per child under 18. The report is available <a href="here">here</a>.

**Leicester City Council granted new powers to control 'To Let' boards** - Leicester City Council has been granted new powers to stop landlords putting up boards advertising their properties in some parts of the city. The council successfully applied to the Government for a Regulation 7 direction which will effectively ban the use of 'To Let' boards in some areas around the University of Leicester and De Montfort University. #### Homelessness

£30 million immediate support for rough sleepers - 83 areas will share £30 million to boost the immediate support available to people living on the streets and help them into accommodation Housing Secretary Rt Hon James Brokenshire MP confirmed on 9 June 2018.

Councils across England with the highest numbers of rough sleepers will receive a share of this funding to significantly increase the support they are able to offer people now and also those at risk this coming winter.

Funding will be used to provide an additional 1,750 additional bed spaces for rough sleepers and an additional 531 dedicated homelessness workers. The funding will also help improve the co-ordination of services available to those in need and at risk. Full details available from <a href="https://example.com/here.">here</a>. Projects include;

- **Leicester** will receive £265,000 to increase outreach provision, create a Rough Sleeper Co-ordinator role and establish an innovative "Housing Led" scheme enhancing options for those sleeping rough in the city
- **Lincoln** will receive £376,000 to increase outreach and specialist support provision; the funding will also provide 15 bed spaces for rough sleepers with complex needs and create a Rough Sleeper Co-ordinator post
