FINANCE SETTLEMENT EXPECTED TO BE RECEIVED IN MID-DECEMBER

Council chiefs have been told by Whitehall officials they may have to wait until 19 December to receive the finance settlement.

This goes against the recommendations of the 2018 Hudson review into how the Government oversees the sector's finances, which recommended 5 December for the provisional settlement. Whitehall previously promised to bring forward the settlement and carry out a postimplementation appraisal of the Hudson review. It is not known if this work ever took place, and

officials now say the timings of the settlement are bound by the Spending

An MHCLG spokesperson claimed no date had been fixed for the settlement.

REFORMS TO FLOOD FUNDING AND INVESTMENT TO PROTECT FARMING COMMUNITIES

The government announced this week that £50 million of funding will be distributed to internal drainage boards (IDBs), the public bodies responsible for managing water levels for agricultural and environmental needs in a particular area.

The funding will help projects that will improve, repair or replace IDB assets - including flood barriers, embankments and maintenance of watercourses. The funding will support projects which reduce risks and impacts from flooding to farmers and rural communities across England. The government has also committed to look at the funding formula for allocating money to proposed flood defences. A consultation will be launched in the new year which will include a review of the existing formula to ensure that the challenges facing businesses and rural and coastal communities are adequately taken into account when delivering flood protection. The government has also today confirmed payments to farmers impacted by last year's severe weather through the Farming Recovery Fund are expected to land in farmers' accounts from 21 November.
