Building Safety Levy – New Burdens Funding Update

This week, MHCLG wrote to councils to confirm the updated new burdens grant allocations for councils with building control responsibilities. The funding will cover councils' set-up costs in preparation for them acting as collection agents for the building safety levy. Parliament approved the Building Safety Levy Regulations in Autumn 2025, and grants will be paid in April 2026. The levy will be charged on new residential floorspace in England on the 1 October..

Changes to Leaseholder system announced

This week, the Prime Minister announced changes to the leaseholder system. Ground rents set to be capped at £250 a year, new leasehold flats will be banned, and homeownership strengthened. Forfeiture for leaseholders will also be abolished.

Consultation on Children's social media usage

Last week the government announced a consultation on children's social media use and phone bans in schools to protect young people's wellbeing and ensure safer online experiences.

The consultation on children's use of technology will seek views from parents, young people and civil society – with the first events in a nationwide tour to be held in the days ahead. The government will respond to the consultation in the summer.

New member for Highways in Lincolnshire

A new executive member for highways has been appointed in Lincolnshire. Cllr David East will take on the position after Michael Cheyne announced his intention to step down from the role at the next full council meeting on Friday, 20 February 2026. Cllr Cheyne will remain a representative for Boston West.

£500m budget approved for major transport and growth investment across the East Midlands Combined County Authority.

EMCCA has approved its budget for 2026/27, with £500m set to support a range of transport and regeneration projects across Nottingham, Nottinghamshire, Derby and Derbyshire. The budget includes £290m capital programme, with more than 70% focused on transport infrastructure and better connected communities, £120m for the four highways authorities for road maintenance.
