This course gives attendees an overview of the situation in the UK in relation to child trafficking, its different forms and their dynamics. The second session outlines best practice in safeguarding and disruption responses to child trafficking and exploitation.

2. Child criminal exploitation and trafficking

This course focuses on the specific issue of child criminal exploitation (CCE) in the UK. Module 1 reviews the different forms of CCE, their dynamics and methods of control. In Part 2 we consider best practice in safeguarding children and disrupting trafficking, with a particular focus on non-prosecution for child victims of trafficking and working with those already in the Youth Justice System.

This course is ideal for safeguarding, youth justice and legal practitioners who encounter children vulnerable to CCE in their work.

Module 1: An Overview of Child Criminal Exploitation in the UK, its forms and dynamics.

3. Safe accommodation and missing child victims of trafficking

This course is based on our influential research with Missing People UK into child victims of trafficking going missing from care. It outlines best practice when caring for and accommodating child victims of trafficking, as well as explaining why trafficked children go missing and best practice in responding to and preventing children from going missing.

This course is ideal for those involved in the care of children at risk of trafficking, such as Looked After Child and fostering social workers, foster carers, care home staff and missing persons practitioners.

Module 1: Providing safe accommodation and care for child victims of trafficking

4. Spiritual abuse and child trafficking (Single module)

Based on our experience of working with victims of child trafficking, this half-day course looks at the particular relationship between spiritual abuse and child trafficking. It aims to provide an understanding of the interlinkages between the two, their dynamics and effective responses to this particular issue.

This course is ideal for those working with child victims of trafficking and exploitation where spiritual abuse is a particular concern. It is recommended that you have a solid understanding of child trafficking, modern slavery and exploitation prior to attending this course (for example, by attending Module 1 of our 'Overview' course as a minimum).
