# **Statutory Guidance on Overview and Scrutiny**

This week the Government has published the 'Statutory Guidance on Overview and Scrutiny in Local and Combined Authorities'. The report available from <a href="https://example.com/here">here</a>. Key points include:

- councils should adopt a position of sharing any information asked for by their scrutiny committee, and if information can't be shared in public they should consider sharing it in a closed session
- scrutiny committees should be constructive 'critical friends' with a vital role of amplifying the voices and concerns of the public when councils take important decisions
- local authorities should also consider whether contracts with companies delivering services should include a requirement to supply information to scrutiny committees

# **Home Office UASC Funding Review Announcement**

The long-anticipated results of the Home Office's review of UASC funding were announced on this week by the Immigration Minister. The Home Office announcement is <u>here</u>.

In summary:

- The lower, Legacy rates have been removed, as has the age differential in the National Rates. From 1<sup>st</sup> April 2019, all UASC will be funded at £114 per child per night
- Nationally, approximately 80% of UASC are 16 and 17 years old so this uplift will apply to them and the overall additional funding is over £30 million per year
- In the East Midlands currently, 86% of UASC are 16-17 year olds, so the new funding represents a £2.24 million boost across the region to Children's Services' budgets
- The funding is still intended as a contribution by the Home Office to local authority costs rather than full cost recovery, although it is now closer to that.
- The national review of former UASC care leavers remains on-going

A letter from the Minister has been sent to Council Leaders and Chief Executives.

EMC welcomes the Government's recognition that it costs local authorities the same to care for and support 16-17 year old UASC as it does for those under 16, and that the existing levels of financial support have failed to cover the significant cost incurred by councils in caring for these very vulnerable children.

We would like again to thank everyone who contributed so much to the East Midlands Councils' report on Local Authority UASC costs, which was submitted on behalf of the region to the Home Office as part of this review. Regional work to determine the costs to councils of supporting former UASC care leavers is continuing and we will work constructively with the Home Office as they review these cost pressures.

#### **East Midlands Rail Franchise**

Abellio has been confirmed as new operator of the East Midlands Rail Franchise from August 2019 [details <a href="here">here</a>]. Council leaders will meet the new team at the Transport for the East Midlands (TfEM) meeting on the 5<sup>th</sup> June to discuss plans for improving rail services across the East Midlands. The meeting will also consider a draft Partnership Agreement with DfT which will enable TfEM to have an ongoing role in the management of the franchise to ensure it delivers for local communities and businesses, and to drive incremental improvements over and above the franchise agreement.

#### **EMC Nominations**

East Midlands Councils seeks nominations and expressions of interest once a year in May (after the elections) for the following:

**EMC** - These 46 places are appointed by 'one place per authority' which is usually the Leader of the Council unless otherwise specified. In addition to this there are an additional 46 added places that are allocated on the basis of the political balance of the region (not authority) and members are invited to express an interest in these places. There are 2 EMC meetings a year (July and February).

**EMC Boards** - Nominations are also invited to the following Boards. These places are worked out on political balance of the region. Members must complete an "Expressions of Interest" form in order for their name to be put forward.

Around £200 million will be made available to remove and replace unsafe aluminium composite material cladding from around 170 privately owned high-rise buildings [details <a href="here">here</a>].
